1. NAME: The name of trust shall be RAMJAG SINGH, MAMORIAL TRUST.
2. OFFICE: - The registered office at the trust shall be at BASTIPUR, DEHRI, DIST- ROHTAS in the State of BIHAR, the trustees by unanimous decision may change the place of registered office of the trust.
3. DATE OF COMMENCEMENT: The day of commencement of the Trust Is 8<sup>th</sup> September 2011.

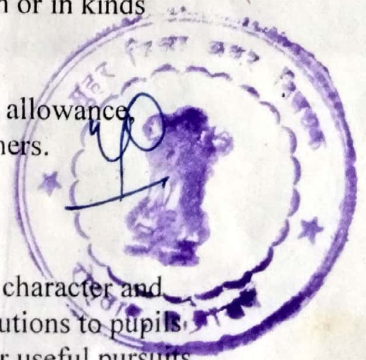
OBJECT :

The object for which the trust has been established is to provide educational, Medical care and to undertake any other object and sociseconomic upliftment of the people and furthering at any other object of general public utility not involving carrying an any activity for profit and for such purpose, throughout the country.

- I. To establish, promote, support, maintain and run educational institutions and other establishments for giving education to the public on no profit no loss basis.
- II. To establish, promote, support, maintain and run, hospital, nursing home and other medical establishment for giving medical treatment to the public as charitable organization.
- III. To provide education, medicines, food, clothing, water, light and of shelter for the poor and of needy persons and to give help to them either in cash or in kinds otherwise as charity.
- IV. To grant scholarship, stipends, free. Studentship, prize, rewards and allowance, financial and other assistance to students, lecturers, professors, teachers.
- V. To organize training and employment for woman youth etc.
- VI. To engage teacher, professors, instructors and expert of good moral character and conduct able to impart efficiently and economically up to date institutions to pupils and students in modern science, research work, intellectual and other useful pursuits.
- VII. To develop a healthy as well as critical attitude to wares the development of mental,

Physical and moral uplifts of the students and all those connected with the institution so as to make them good citizens.

- VIII. To established, maintained and run a boarding house and residential institution for the students and those connected with the institution.
- IX. To conduct educational tours all debates for the expansion of knowledge and betterment of the students.
- X. To collect and received donations, contribution, subscription, bequest, grants aid, other aid, assistance in cash or kinds form all persons and institution interest in the object of the trust.
- X. To take or accept donation, loan, subsidies, aids, assistance (both monetary and in kinds) from whatever source available.

#### FUND:

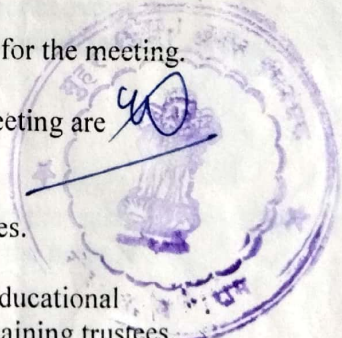
- I. The amount settled by the settler on the trust today amounting to rupees ten thousand will be the initial corpus of the trust and the trustee are hereby further empowered to collect donations from Govt, public and other persons in the manner they desire.
- II. The corpus or fund of the trust not immediately required are to be deposited in the bank or to be invested in any govt. security to which the trust is entitled.
- III. The trustees are empowered and maintain account or accounts and to authorise any two trustee to operate the same.

#### MANAGEMENT

- I. The trust shall be managed by the board of trustees.
- II. The maximum number of trustees shall be seven and not less three at any time.
- III. The trustees will hold their meetings at least four times in a year but not more than an interval of four month.
- IV. The preserve of three trustees personally present will be the quorum for the meeting.
- V. Any Trustee may resign from the trustship and the trustees in the meeting are empowered to accept the same.
- VI. The trustees are empowered to fill up the vacancy in board of trustees.
- VII. Any person at the age of 21 years or beyond having interest in the educational activities and object of the trust can be taken as a trustee by the remaining trustees.
- VIII. The trustees who are found to work against the object to the interest of the trust may

be removed by two – third Majority of the trustees in their meeting but before that the trustees are required to give notice to such trustee for the lapses on his part.

- IX. Any trustee who is leaving India for and or who remains absent continuously in three meeting without permission can be removed from the trustship of the trust.
- X. The trustees are empowered to reimburse for the expenses incurred for the trust and its activities out of their own funds.

#### ACCOUNTS:

- I. The trustees shall maintained true and fair accounts of all receipt and payments of the trust and account. So maintained shall remain at the office of the trust.
- II. The accounting year of the trust will be from April to March of years and the first account of the trust shall close on 31 March of 2012.
- III. The trustees are empowered to appoint C.A.
- IV. The account so prepared and audited shall be placed before the special meeting of the trustees within three month of the closure of the accounts along with the report of the auditors.

#### TRUST MEETING:

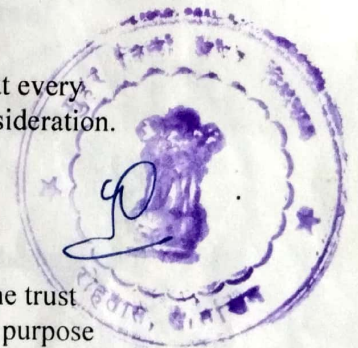
- I. The trustees shall meet every quarter for the trust and its found.
- II. The decisions are to be taken by Majority.
- III. The personal preserve of three trustees will be for the corum for a meeting.
- IV. Such meeting is to be called by giving seven days notice to the trustees but special meeting can be called by a short notice of 12 hours.

#### SPECIAL MEETING:

- I. The trust will have been a years its special meeting before 31. October at every Years in which the audited accounts at the trust are to be placed for consideration.

#### ENVESTMENT:

- I. The fund collected for the trust shall be utilised for carrying an object the trust of acquiring the capital assests of constructing the building e.t.c. for the purpose of the trust.
- II. In case any surplus remains trust the same will be invested in Govt. securities permitted for a trust or to remain in bank in F.D.and S.B. Accounts.

### NATURE OF TRUST:

- I. The nature of trust is public charitable trust and benefit of trust shall be available to the beneficiaries without any destruction of cast, creed, religion or sex.

### AMENDMENT IN TRUST DEED:

- I. The trust deed can be amended by two-third Majority of the trustees in a meeting specially called for the purpose by giving 14 (fourteen) days notice for the purpose and the resolution passed by such majority as circulated with or without notification shall be final and binding for good for this deed.

### POWER OF TRUSTEE: -

- I. Overall control of the trust shall be in the trustees who will exercise their power and control through the Executive Committee at the trustees appointed by them for the purpose of though the office bearers elected by themselves out of them.
- II. The trustees with have the following power in general: -
  - a. To raise, collect, arrange for the donations for the benefit of trust and invest such fund from time to time.
  - b. To decide about the educational activities and other undertaken by the trust.
  - c. To make rule for running of the institutions or giving donation or appointment of the offices and teachers as well as for the meeting held by them.
  - d. The trustees are empowered to appoint or terminate the employ of the trust.
  - e. The trustees are further empowered to open and operate Bank account or accounts with any Schedule Bank and may exercise/ authorise either of them to operate the same jointly with any of the trustee but in case of joint operation signature of treasure would be essential.
  - f. The trustees are empowered to donate the fund to a trust having similar objects.

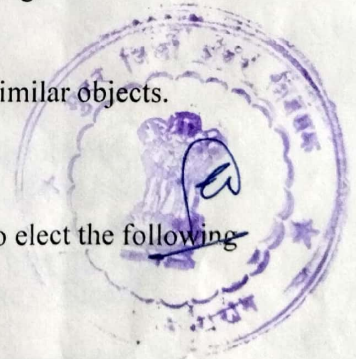
### OFFICE BEARERS

The office bearers so elected by them shall hold office for a period at the two years and every second year in the month of October there will be a fresh election but the retiring office bearers may re-elected in the meeting called for election at the office bearers.

The chairman of the trust will be the virtual head of the trustees and will provide over all the meeting of the trust.

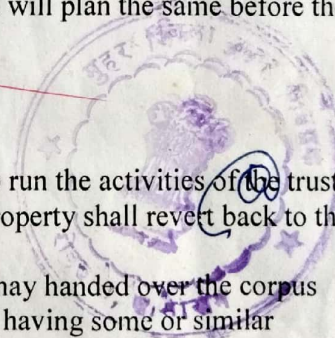
The vice chairman of the trust shall act in the absence of the chairman and in his absence all meeting are to be provided by the Vice Chairman the trustees are empowered to elect any one out of them to provide over the meeting.

- I. The Board of trustees are empowered to elect a managing trustee out of themselves to manage the affairs of the trust and to look after its remain in the custody at managing trustee. The managing trustee is entitled to call for meeting of the trust under the permission at Chairman.
- II. The managing trustee shall be empowered to represent the trust in all cases before any court or authorities.
- III. The managing trustee shall prepare the annual report of the trust and plan the same before the board of trustees.

Out of trustees, the trustees are empowered to elect one treasurer who shall be responsible for keeping all records and maintain the account of all receipts and payments. He will be required to annual budget of the trust and will produce it before the special meeting of the trust for the approval. The treasurer will also be required to prepare the final accounts to get the same audited by the auditors appointed by the Board of trustees and will plan the same before the special meeting of the trustee.

- I. The trust can wind up its affairs if it finds it difficult to run the activities of the trust any more but no part of the funds of the trust and its property shall revert back to the trustees.
- II. In care the trust decided to winding up its activities it may handed over the corpus of the trust and its assets and liabilities to another trust having some or similar objects.
- III. The Board of trustees shall call the extra ordinary meeting of the trustees for the purpose of giving 14 days notice to the trustees and a resolution passed two thirds majority of the trustees present shall be requirement for winding-up of the trust.

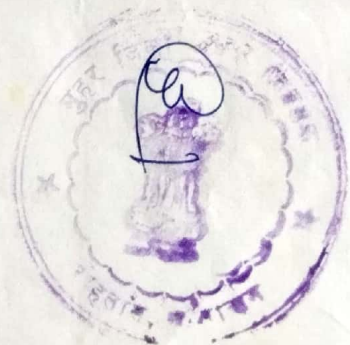
